Christian Motorcyclists' Association (UK) regards safeguarding and good working practice as a priority. In the interests of the safety and wellbeing of all vulnerable adults, children and young people, it has developed and operates a formal safeguarding policy, which is registered with 'Thirtyone:eight' (formerly the Churches' Child Protection Advisory Service).

The association is committed to ensuring that everyone working with vulnerable adults, children or young people:

- Has undergone a Criminal Records Bureau check at enhanced level.
- Is adequately trained and supervised.
- Understands and follows the Association's safeguarding policy.

- Is committed to supporting, training and resourcing those who work with vulnerable adults, children and young people and provide regular supervision.
- Will review its safeguarding policy annually and register it with 'Thirtyone:eight'.
